To avoid a refund delay, use your account statement to verify your correct account number and account type and include NEFCU's Bank Routing Number: 221480807. If you work with a tax preparer, you can provide him/her with a voided NEFCU check, since it includes both your checking account number and NEFCU's Routing Number.
